A MESSAGE TO OUR MEMBERS

25 Years of Charging Forward... Together

It's hard to believe, but we reached two major milestones at the end of

2022. The first was the **85-year anniversary** of when rural electric cooperatives were formed, including Ida County REC, O'Brien County REC, Plymouth Electric Cooperative and Sioux Electric Cooperative. The second important milestone was the **25-year anniversary** of the consolidation of those four cooperatives to form North West REC.



The consolidation went into effect on **January 1**, **1998**, following a favorable vote of over **85% of the members** of those cooperatives to adopt a Plan of Consolidation that had been proposed by the boards of directors.

The goals of the Consolidation included **gaining efficiencies** in order to keep costs down, **rates affordable**, and **to improve reliability** and services for the member-owners. We believe we have met those goals. Savings have far exceeded the original projections which has enabled us to have rates that are the lowest in Iowa and in the bottom 5% nationally of the 800 REC's.

We have also been able to maintain very good service reliability for our members, and we continue to make improvements in this area. We have seen our total utility plant go from \$38 million in 1998 to \$105 million today. This demonstrates the strong commitment the board of directors has to maintaining a reliable electric distribution system. In addition to these investments, our power supplier, NIPCO, has been making significant investments over the years to upgrade and maintain the transmission and substation network.

Many things have changed over the last 25 years. The size of many of the electric loads we serve are much larger than they have been in the past and require an even higher level of reliability and power quality. Some members have installed distributed generation resources and others are looking at purchasing electric vehicles. These kinds of changes impact the generation, transmission and distribution of electric service to our members. As we adapt to these changes, we want to assure you that our commitment to providing reliable electric service for our members at the lowest possible cost has not changed. We pledge to keep charging forward . . . together. Inspired by our past . . . powering your future.





2022 ANNUAL MEETING MINUTES

The Annual Meeting of the members of North West Rural Electric Cooperative was held at the Skate Palace in Ida Grove, Iowa, Ida County, Iowa at 6:30 o'clock p.m. on the 31st day of March, 2022. Members could come to the meeting in-person or members could view the meeting virtually online on the North West REC website or the North West REC Facebook page.

Welcoming remarks were extended by Jeff Rehder, Board President.

The Pledge of Allegiance and an invocation were offered by Dale Ullrich, Board Director.

The meeting was called to order by Jeff Rehder, Board President, who presided, and Steve Brown, Board Secretary, acted as secretary of the meeting and kept the minutes thereof.

Secretary Brown then read a copy of the Notice of the Annual Meeting, together with proof of the due mailing of said notice, to all members of the cooperative, and such notice and proof were ordered to be annexed to the minutes of this meeting.

Secretary Brown reported that return of over 10% of the mailed ballots established a quorum for the transaction of business.

Secretary Brown reported that the minutes of the annual meeting held on March 30, 2021 were included in the annual meeting mailing that was mailed to all members. A motion was duly made, seconded, and carried to waive the reading of the minutes, and they were thereupon declared to be approved and were ordered to be filed in the records of the cooperative.

The closing of the balloting for the District 1, 2, 3, and 4 director positions was announced by Jeff Rehder, Board President.

Manager Korver introduced the directors who were present at the meeting.

Executive Assistant, Renee Wynia, announced the 2022 scholarship winners from each district.

Jim Holst, chair of the Nominating Committee, reported that the Nominating Committee met on January 18, 2022, and placed the following names in nomination for the election of directors to the Board of Directors

of the Cooperative to be voted on, elected, and ratified at this meeting.

The Report of the Nominating Committee was ordered to be identified by Secretary Brown and annexed to the minutes of the meeting.

Tom Wagner, Board Treasurer, gave a brief financial report of the cooperative.

A 2021 Highlights Video of North West REC was shown.

Manager Korver, President Rehder, Treasurer Wagner, and Matt Washburn, NIPCO Executive Vice-President participated in a Questionand-Answer Panel Discussion. Question cards were mailed to each member with the Annual Report prior to the meeting, and members could send in a question. The panel addressed and answered some of the questions from the membership.

Jim Holst, chair of the Nominating Committee, presented the Certificate of Inspectors of Election, certifying that according to the number of votes received: Jeff Rehder was elected as director for District 1, Tom Wagner was elected as director for District 2. Steve Brown was elected as director for District 3, and Dan Hoffman was elected as director for District 4, all for a four-year term. The Board President then directed the Secretary to annex the Certificate of Inspectors of Elections to the minutes of the meeting and thereupon declared said members duly elected as directors of the Cooperative to hold office for the term specified and until his successor shall have been elected and qualified. A motion was made, seconded and carried, to approve the Inspectors of Election Report.

There being no further business to come before the meeting, upon motion duly made, seconded and carried, the meeting adjourned.
